It may clearly be noted that wherever Not Recommended (NR), Not Considered (NC) has been mentioned, in column 5 of the enclosure, the concerned institute may be instructed not to admit the trainees from the next session and the trainees if any, undergoing training in such tradaes/units in such (TIs shall not be permitted to appear in All India Trade Test by NCVT. It has also been observed that some State Directors allow the trainees of unaffillated institutes/ trades to appear for NCVT examination. This should not be done at all. In this connection, it may be stated that as a result of this irregularity committed by some State Directors, DGET

- a) had to change the procedure for issue of National. Trade, Certificates and such trainees will not be given NCVT certificates and;
- b) is facing a lot of Court Cases.
